#### Mandatory Participation

- Participation in the courses and e-learning activities according to the study plan and completion of the performance assessments are mandatory for all participants.
- Components of the study program that require active participation must have been completed to a total of at least 80%. "Active participation" means either mandatory attendance or mandatory activities on the e-learning platform such as completing exercises, quizzes, discussions, group work and others. Pre- and post-assignments are considered course components.
- The sitem-insel School reserves the right to conduct courses exclusively on site, online and/or hybrid.

#### Fees and Cancellation

- Scholarship recipients have competed against other applicants and are thus expected to successfully complete the program. In the case of withdrawal of a scholarship recipient, the course fees for the entire study program will be charged in full (i.e. CHF 31'500.-) to the recipient.
- If a replacement can be found for the deregistered person, processing costs of CHF 200.- will be charged. Whether the replacement is suitable is at the discretion of the directorate of the sitem-insel School.
- There is no entitlement to a refund or waiver of the course fees if parts of the course are not attended.
- The conclusion of a cancellation cost insurance is left to the individual participants.

#### Duration

- The standard period of study for the MAS program is four semesters, the maximum period of study is five years.
- Scholarship recipients are expected to complete the MAS program within the scheduled standard period of study of four semesters.
- In the case of an exceedance of the maximum period of study, the course fees for the entire program will be charged in full (i.e. CHF 31'500.-) to the scholarship recipient.
